FULL — Individuals over 15 years of age, voting rights and clown name protection in CCA (subject to approval per by-laws), reduced or free admission to special CCA sponsored educational events. MUST be COAI member and provide Proof of COAI membership with application or renewal. Eligible to serve on the CCA Board (age 21 or over) after being a CCA member for one year.

ASSOCIATE — Individuals over 15 years of age, may be non-clown (no photo required), has no voting rights, no clown name protection in CCA, no COAI membership, may be required to pay higher admission charge for special CCA sponsored educational events and are not eligible to serve on the CCA board.

FAMILY — Individuals over 15 years of age residing in the same household with a parent, spouse, or adult sibling who is a FULL or ASSOCIATE CCA member. COAI membership is optional, but is required in order for Family member to have voting rights and clown name protection in CCA (subject to approval per by-laws) and to be eligible for free or reduced rate admission to special CCA sponsored educational events and to be eligible to serve on the CCA board (board members must be at least 21 years of age).

JUNIOR — Individuals ages 8-15 COAI membership is optional, but Junior must be a COAI member to have voting rights and clown name protection in CCA (subject to approval per by-laws) and be eligible to attend special CCA sponsored educational events free or at reduced rate. Junior members are not eligible to serve on the CCA board of directors. A sponsor is required who is a CCA member at least 21 years of age. Name of Sponsor: _____
